BAN ALL FORMS OF HUMAN CLONING IN WISCONSIN

We, the undersigned, call upon the Wisconsin State Legislature to enact legislation banning all forms of human cloning. We recognize that forming humans “in vitro,” through cloning or other means, is a root cause of deadly human embryonic stem cell research. Human life is not a commodity. The dignity and individuality of the human person must never be disregarded – in the case of “reproductive” cloning where a cloned person is brought to birth, or denied – in the case of “therapeutic” cloning where the cloned person is sacrificed in the name of scientific progress. All human life deserves legal protection.
